When and where the insurance is valid

Business Travel: The insurance is valid on global travels with duration up to 180 days, including short day travels within the country/zip code area the insured is living, working, or studying.

Leisure Travel: The insurance is valid on global travels with duration up to 90 days, including short day travels within the country/zip code area the insured is living, working or studying.
